Building and Grounds Report: Lloyd Weeks is absent, report given by Brian O'Connor

The Pool house was painted by volunteers on Sept. 24th at no cost as we had left over paint from the main clubhouse. There was a leak with the dishwasher in the kitchen that was fixed. They received an estimate for doing the tennis courts from a paving company. Both sections for \$36k. May be able to be done in the Spring. We are waiting on the results of the Asset Comm. to determine what we will do. The reserve fund will be fine as we have been planning for this. We're actually ahead of schedule as far as

our asset maintenance. New gutters are to be installed on the pool house. As far as installing internet service to the clubhouse, they have to drill under the road to run the lines to the clubhouse. This is done by a contracted company and we are waiting for them to do the work before we can get it installed. The cost of the internet meets the criteria set out at the last meeting. The dump is getting a load of gravel soon. Regarding a pool cover, Lloyd is getting a good deal next year so it is in next year's budget.

Sandy Woodall of the Asset Improvement Com. reported that they have finished with their communication part and will be putting together a report by Oct, 21st to Ben.

Ben reported that they have been looking into having removeable speed bumps installed by VDOT for the Summer time. He will report back when he knows more.

Clubhouse Report: Cindy O'Connor

There are \$559 in the clubhouse fund. There are 2 rentals scheduled for October. The Halloween Party will be Saturday 10/29 at 5:30pm with a cost of \$10/person. She needs volunteers to help set up. The Christmas party is going to be Dec. 18th at 2pm. No cost. Asking folks to bring a side dish or dessert.

Web Site Report: Tommy Bowlin

The Facebook page currently has 114 members and is used often by our neighbors. Two requests were denied as the questions hadn't been answered. The website has had hits in September. YTD we've had 1,110 visits, 4,894 views. He asked about setting up the messenger service for the FB account but the group thought that wasn't a good idea. It was requested to add the hunting notifications online.
