There are \$300 in the clubhouse funds. There are two rentals in April. On April 23 at 6:30pm there will be a Casino Night held at the clubhouse to raise money for a new pavilion at the beach. The pool opening party is to be announced later. Saturday May 7th is the Kentucky Derby party at the clubhouse.

Web Site Report: Tommy Bowlin

Website visits have been averaging 3 per day from the middle of March, 38 visits since April. 72 members of our FB group and it seems to be used a lot. Tommy is going to put a calendar on the webpage of our events.

Unfinished Business

Neighborhood dump- discussions

- 1. Covenants rewrite- Ben is still working on that. Will update the board when more is known. The changes will require Association approval with notarized signatures.
- 2. Public Utilities Easements and Drainage Easements- Ben has spoken with the County official on them and now has a plats of where they are in our neighborhood. The County permit process takes into consideration where easements are before approving a building permit. Some front setbacks have increased to 30 feet.
- 3. Clubhouse painting-Spring dates for painting the clubhouse and needing volunteers are April 25th and 30th.

New Business

- Ben has received numerous complaints about the tree cutting that has taken place on
 Timberwood Rd near the turn off for the marina. It looks terrible. He is going to reach out to the
 County supervisor to see if there is anything that can be done to have the owner make it look
 better. The Board empowered Ben to speak on their behalf regarding the issue.
- 2. Dog Park instead of tennis courts- Discussions will be had at a later date.

General Information from the Floor-

A Neighbor complained about the speeding of cars in the neighborhood particularly from short term renters, could anything be done. Asking John Maddox if additional signage could be installed that shows people their speed in real time. He said he would look into it. Also regarding signage, the sign telling folks where the public boat ramp is gets missed all the time. Could it be moved to be more obvious?
